## **SELECTION ANNOUNCEMENT**

Deadline to send photo works is **October 14th, 2020**.

The winner will be revealed during the prize-giving evening on **November 14th, 2020**.

Works selected by the panel of judges will be promoted by Moak with exhibitions and events as well as through advertising material all over the world.

## **ART.1/PROMOTER AND PARTICIPANTS**

Caffè Moak S.p.A., with the organisational support of Still Love S.r.l., calls the seventh edition of Fuori Fuoco Moak - international photography contest - for the year 2020. The contest is open to all professional and amateur photographers called to narrate a story or develop a photo essay with a sequence of 3 images that refer to coffee. The term "coffee" can be interpreted in a strict sense (plant, seed, drink, public establishment, etc.) or just recalled by the flow of the author's imagination (e.g. through colours or words connected to coffee as a ritual, a meeting, a job, the southern world, etc.). The number of works shall not be less or more than what is indicated, or otherwise will be excluded. All images must be shot in the same format [3:2 portrait or 3:4 landscape].

## **ART.2/REGISTRATION TO THE CONTEST**

The images shall be sent in electronic format only before midnight of October 14th, 2020 under penalty of exclusion from the contest, using the specific registration form, which is available on the official contest website [www.fuori-fuoco.com](http://www.fuori-fuoco.com). Competitors shall fill in the registration form in all its parts.

Participation fee for the contest is € 18,00.

## ART.3/FEATURES OF THE WORKS

The works can be in b/w or coloured and in digital form only.

The images have to be compressed in JPEG [jpg] format, colour profile RGB.

Highest allowed size for each image is 2MB. Allowed are scanned images taken on film as well as those taken directly with digital devices. Pictures awarded in other competitions and pictures taken before December 31st, 2018 are not allowed.

Photomontages, double exposures, solarisations, digital filters or digital retouching, except for slight colour, contrast or exposition corrections, are not allowed, under penalty of exclusion of the work.

## ART.4/COPYRIGHT

Each participant declares to have all rights on the original files and is responsible for the contents of his/her own works, discharging the organisers from any responsibility, even towards possible subjects illustrated in the pictures. The participator shall inform any interested people (depicted people) in the event and case provided for by law, according to art. 10 of the law 675/96 and following modifications with the legislative decree 30th June 2003 no. 196, and also get approval [release] for their diffusion.

By taking part in the contest, the author of each picture grants Moak the right to use the sent material only for purposes strictly connected to the contest.

The digital works will be used for the time needed to set the various competition stages. After the announcement of the winners, works will not be spread or used in any case, except for those expressly agreed with the authors.

As for the publication on websites and magazines, exhibitions or other national and international events promoted or sponsored by Caffè Moak S.p.A., the author of the picture or right holder will be asked for approval, either through a licensing agreement or a release note.

The automatic acquisition of image exploitation rights for

purposes outside of the contest will be related only to the images winning cash prizes and will be in any case quoting the author.
